Description

Introductory description

This module analyses the patterns and characteristics of Islamic economies and their governance in Southeast Asia, with an emphasis on the region's Muslim-majority countries. It investigates common and competing understandings of 'market Islam' and 'civil Islam'; as well as of local and globalising Islamic economies. After briefly reviewing the history of Islam in the region and conceptualisations of state-society-Islam relations with an emphasis on their economic impact, the module will look at a number of topical issues such as halal certification regimes, Islamic finance and religious tourism.

Module aims

This module analyses the patterns and characteristics of Islamic economies and their governance in Southeast Asia, with an emphasis on the region's Muslim-majority countries. It investigates common and competing understandings of 'market Islam' and 'civil Islam'; as well as of local and globalising Islamic economies. After briefly reviewing the history of Islam in the region and conceptualisations of state-society-Islam relations with an emphasis on their economic impact, the module will look at a number of topical issues such as halal certification regimes, Islamic finance and religious tourism.
