Module aims

The module aims to explore the relationship between economics and politics as academic disciplines and real life phenomena through a study of economic policy making; to examine critically theoretical discussions of the relationships between states and markets and the development of economic policy in Britain, and internationally, in the post-war period to the present.

Outline syllabus

This is an indicative module outline only to give an indication of the sort of topics that may be covered. Actual sessions held may differ.

In no set order, topics have included: theories of the policy making process, theory and empirics of

market failure; public choice theories; issues of international political economy and globalisation; bureaucracy and the “core” executive in Britain; the development of governments’ economic policies in recent decades, including the economics and politics of inflation, unemployment, and migration, the welfare state and economic performance, income distribution, corruption, public finance, and regional and global governance.

- ... have an understanding of the differences and complementarities in economic and political modes of analysis; develop a critical understanding of debates about the impacts of policies and policies on economic performance; assess the impact of globalisation on the autonomy of national economic policy and acquire knowledge and analytical skills relevant to careers in government, the media, the financial services sector, business associations and industry

Students are tasked with selecting a policy of their interest and analysing the roles of various actors and institutions in implementing or hindering the policy. These are areas and institutions that would have been discussed in lectures and seminars during term 1.

Students are given the opportunity to choose a particular area of policy that interests them and is related to the topics discussed in term 2. They are then tasked with describing and evaluating the chosen policy, and making recommendations for its improvement.

Students are given the opportunity to choose a particular area of policy that interests them and is related to the topics discussed in term 2. They are then tasked with describing and evaluating the chosen policy, and making recommendations for its improvement.

Feedback on assessment

The Department of Economics is committed to providing high quality and timely feedback to students on their assessed work, to enable them to review and continuously improve their work. We are dedicated to ensuring feedback is returned to students within 20 University working days of their assessment deadline. Feedback for assignments is returned either on a standardised assessment feedback cover sheet which gives information both by tick boxes and by free comments or via free text comments on tabula, together with the annotated assignment. For tests and problem sets, students receive solutions as an important form of feedback and their marked assignment, with a breakdown of marks and comments by question and sub-question. Students are informed how to access their feedback, either by collecting from the Undergraduate Office or via tabula. Module leaders often provide generic feedback for the cohort outlining what was done well, less well, and what was expected on the assignment and any other common themes. This feedback also includes a cumulative distribution function with summary statistics so students can review their performance in relation to the cohort. This feedback is in addition to the individual-specific feedback on assessment performance.
